With two years under its belt, First Floor Fund (FFF) has cemented its success in Dayton. Funded by the Dayton Recovery Plan, FFF has supported a variety of businesses including salons, bars, restaurants, bakeries, and boutiques. CityWide has been at the table and working on the Dayton Housing Policy since its inception. Following the city of Dayton's adoption of the Dayton Housing Policy, CityWide began working on creating a Housing Trust Fund. Through the leadership of CityWide Board Member Amy Riegel, a committed group of local stakeholders met throughout 2024 to create a framework for the HTF and to identify various funding approaches.

"Over the last two years, I have been working with communities across the state of Ohio, to expand funding for affordable housing. New federal and state sources of funding are being developed, however, there is still significant competition to secure these dollars."

"To secure federal and state funding, being competitive in terms of leverage, having local commitments, low-interest loans, and other forms of funding can give a project the edge needed to receive public dollars. The HTF would make Dayton and Montgomery County more competitive by being that source of funds."

The establishment of HTFs has proved to be an accelerator for development, the very type of development needed in Montgomery County.

PACE Direct

Financing Program

The Dayton / Montgomery County Port Authority partnered with CityWide to launch the Property Assessed Clean Energy (PACE) Direct program. This brought together the city of Dayton, Montgomery County, CityWide, and the Port to support its creation and execution. "PACE Direct focuses on smaller sized opportunities for commercial property owners to invest in their properties. It fills a gap in the market – lenders tend to not be as interested in

underwriting deals this size or projects such as the ones PACE Direct can be used for. This particular fund has a focus on energy projects."

Work in DaVinci Continues

New Housing at The Point

With nearly 15 years of dedicated work from CityWide, half a dozen partners, and a slate of completed projects, it's impossible to ignore the success of the DaVinci Project in the Old

North Dayton and McCook Field neighborhoods. New developments in 2024 have only cemented this notion.

The corner of Valley and Keowee Streets is set for new housing to be built. This is a

long-term planning goal of the city and local neighborhood. The project has already received a \$1.5 million investment from the city of Dayton's Dayton Recovery Plan.

"We look for transformative development opportunities, where there is a clear vision and alignment between the city, local economic development organizations, anchor institutions,

> and the local community to achieve it. This project checks all the boxes, and we are excited with what we are planning for the site."

"We expect that this investment, and the

homeownership opportunities that it will create, will continue the momentum that has started in the area."

"It is still early in the project, but we are working to develop a website for the project that will have all the information for people to follow along."

"We will develop 19 market rate, for sale, 3 bedroom, 2.5 bathroom townhomes on the site. The townhouses will enjoy a view of the river and will have private off-street parking in the rear."

Point Park Lands a Funding Boost

In 2024, Point Park received a \$250,000 State Strategic Iniative grant for improvements to the park. These dollars, coupled with a \$650,000 investment from the City of Dayton, continue to turn residents' and stakeholders' visions to reality. This funding will be used to transform an underutilized lot into a flexible parking lot and community space. Elements include a turf lawn, new sidewalks, trees, lighting, and electrical hookups that can be used for food trucks.

West Dayton Continues Building

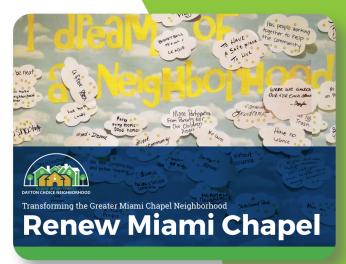
In 2018, the City of Dayton and the Department of Housing and Urban Development adopted the Renew Miami Chapel Plan. Learn how CityWide Board Member Kiya Patrick continues to implement many of the plans' initiatives.

"The Choice Neighborhood Plan created a shared vision for reinvestment in 5 West Dayton neighborhoods. The Plan synergized public, private, and residential partnerships, and those partnerships have been sustained for the last seven years. As a result, the Choice geography has seen investment of over \$85 million since the Plan was adopted in 2018."

"50 units are under construction at the former Daymont West site (1520 Germantown Pike) and will be completed fall of 2025. Construction of an additional 44 units will begin spring of 2025 and will be located at the corner of Danner and Germantown. Funding for the third phase is underway and will hopefully be secured by the end of 2025."

"GDPM's role in community and economic development projects has evolved and expanded over the years, particularly in response to shifts in policy, funding mechanisms, and the increasing recognition of the important role housing plays in economic development. As federal funding for public housing has decreased, GDPM has expanded partnerships with private developers and nonprofit organizations such as CityWide to help finance and implement projects. These partnerships have enabled GDPM to access private capital and expand capacity."

"As the cost of housing and rent continues to increase, quality affordable housing for all income levels is critical for keeping communities stable and economically integrated. Additionally, housing affordability at all income levels can support workforce development and talent attraction strategies for local businesses."

Wright Dunbar Sees More Investment

A new park is coming to Wright Dunbar! Medal of Honor memorial will be erected at Friendship Park. The Park is located at the intersection of W Third Street and Edwin C Moses Boulevard. This intersection is a key gateway for the Wright Dunbar neighborhood. Recent investments here include the complete reconstruction of the Third Street Bridge, also known as the Peace Bridge, and the installation of a sculpture depicting the 1905 Wright Flyer III.

Decades of thoughtful planning are paying off for the Wright Dunbar neighborhood. It seems each year brings new development and 2024 was no exception. One of the most notable projects in the neighborhood is the construction of new, market-rate housing on West Third Street.

"We have been looking in the Wright Dunbar neighborhood since 2019, the business district and strong residential neighborhood made for a strong case that townhomes would be successful."

"New housing opportunities mean built-in patronage for the immediate businesses along the W. Third St corridor. When businesses depend on "outsiders" coming into the neighborhood, sometimes those businesses fail, we hope that having 26 new homes along W. Third St will help bring more business to the small shops, restaurants, and businesses in the Wright Dunbar neighborhood."

"I see Wright Dunbar as an extension of downtown. I see walkability between W. Third St to downtown and more housing opportunities."
